³ A maximum of 15,25% of the total allocated amount may be deducted for indirect costs. This corresponds to a supplement charge of 18% on the direct costs.

⁴ Planning grants under PHO may deduct the full actual cost for indirect costs at the administering organization.

⁵ A maximum of 25 % of the main and co-applicants salaries may be covered by the block grant and a maximum of 25% of the block grant may be used for this purpose.

⁶ A maximum of 25 % of the main and co-applicants salaries may be covered by the block grant.
